

Bennett, Grand Master, 1950, wrote that Masonry's aim is: "... to make of its members men who will always subdue their passions to the dictates of their reason; fearless men of conviction, who will fight evil wherever it may be found; men who, with faith in God and a firm belief in those self evident truths taught within our lodges, will go forth and preach them outside, in words as well as in deed."

In Due Form

The Seven Last Words (and some garbage thoughts of a traveler one Good Friday)

Father, forgive them for they know not what they do. Forgiveness is among the plain and important messages of the Lenten Season. Catholicism preaches "that right up to his final hours on earth. Jesus of Nazareth asked His Father to forgive but it is His very sacrifice on the Cross that mankind is able to be forgiven." It gains more meaning even if the supposedly errant person does not recognize his fault. How do we fix a purportedly crooked situation when someone sees that it is verily a straight line yet who is bold enough to claim as the sole jury of righteousness? The truth is, diversity of cultures or beliefs which is a classic asset of Freemasonry is sometimes its worst nightmare. A "holy cow" is the core of faith in specific religions but it is just a street idiom of the Boy Wonder in Gotham City and a delicacy in the menu of Ambrosia and Elar.

But on the boiling point of conflicts, shall we flash the dirty finger and fold the eager fists? Never in the Craft. In the Scottish Rite, and even dur-



ing the days when "intolerance, bigotry, and oppression" walk on the face of earth without their shirts on, we humbly hold on to the faith "that the hand of God shall strike at the heart of spiritual tyranny and oppression" and whisper the magic word "Nokum Adonai" or "Vengeance is Thine, Oh Lord". Lest in fighting intolerance, bigotry, and oppression, we ourselves become the intolerant, the bigots, and the oppressors whom we strive very hard to exorcise. After all, the roughest squabble also troubles the smoothest mansion but the good news is that nothing is beyond forgiveness among members of a family, and nothing is beyond redemption within the unimaginable possibilities of a lifetime.

2. I assure you, on this day, you are with me in paradise. Faith can move mountains. Faith can heal sore eyes. And faith can take us to paradise. But at first glance, these "last words" are like explicating man's faith as a sheer hunch. Who could, after all, have a nice, first impression on the Son of God wearing a crown of thorns, bleeding profusely, and nailed on a cross between two felons. But that is how it works. Faith is nothing less

than a gut whispered by heaven. The promise of paradise may sound out of this world, way beyond algebra, extremely ahead of one's time, or too under-dressed for the occasion but it is the reason for humanity itself.

In a fraternity, we just close our eyes and take heart that even if we eject ourselves out of a canon, a hand would catch us in mid-air and that even if we are way too drunk to swig a Tequila shot for the road, someone would take the challenge for us and turn the jigger bottoms up. We can trivialize some of life's deepest mysteries but the basic reality in the midst of these hullabaloos is that believing in something or someone has made man survived his life. In today's e-age, it is the only app explaining how he is able to brave the storms and how he still sees a rainbow after each of them. And I doubt if a time would ever come when this widget would need an update.

3. Mother, behold thy son. Son, behold thy mother. Freemasons' reverence for women, particularly for the mother, wife, and daughter/s are unprecedented. In the Craft and its Symbols, it is written that as early as Phytagoras, "women are considered equal with men." From a beermate in Sessions, it is the only organization where a member cares less if he would go to heaven or hell after his death because he is sure that his widow and orphan/s are in the caring hands of his Brethren.

From another perspective, this scene is the point where a son stands face to

face with his Mother Lodge to know her dearly and more. But we have long history of hearing the well-meaning phrases "for the lodge", "for the good of the lodge" or "for the love of the lodge" but saw catastrophic results when these formulas were removed from the test tube. The commonality of good intentions and the variances in the ways to concretize them do not at all add up to refine the Lodge. But notwithstanding these clashes, it is still a good reckoning point. It is a realization that we are different but still the same, that we are worlds apart but still sitting together, and that we may not see eye to eye but still looking at each other. As in every home, all that a Mother wants is respect for each other's person, dignity, beliefs, and hairstyle. Divergence is unavoidable. Disagreement is inevitable. But harmony is not impossible so long as nobody insists that Meteor Garden is better than Casa Blanca. A mother's genuine smile knowing that her children got each other's back is the Eighth Wonder of the World with which every son deserves a selfie.

4. Father, why have you forsaken me? While at the outset, these words picket a man's strongest protest of abandonment, they nonetheless speak of a recognition that he is not at all the alpha and omega of the pack, that there is a cause bigger than the self and ego, and that there is a Grand Designer whose handsome plans are just shrouded by the mess of every day's dregs and thrashes.

It also invites an introspective moment when man searches for the slightest hint why the problems from Joppa found their way to his doorstep, and for the wisdom that perhaps empower him to understand them. And more, it reveals his social nature to invite person/s of his confidence to carry out a complex blueprint or just to be with him during trying times. As they say, it takes two to tango. For the Catholics, it takes the collaboration of the Holy Trinity to save the world. To the Masons, it takes at least three Master Masons to compose a Lodge of their kind.

5. I thirst. This is about sensing the weaknesses, frailties, and imperfections of being human, and the acceptance of the desirability of fulfilling one's needs. At times though, the same could only be gratified through the intervention of another. Easily, someone's congenial deed in relation to someone else's longings quenches an abiding thirst and offsets an imminent distress. These happen on fellowships when a Brother immerses with the others, opens up his life, and allows himself to be known by them and the process just circles among the rest. A Brotherhood in action is the positive outcome where he offers his hand to those who need them and he is likewise aided at such point when he makes a call. In himself, he gains strength and with the others, he gains more.

But sometimes, we ask for water and we get vinegar. We received anchovies when we ordered for marlins. Yet difficulties are just parts of a level in any game. Removing challenges in a play is to register boredom as a teammate. Every Brother looks forward with excitement to a fellowship as much as, or probably more than, he does to a stated meeting. After a grueling month of fatiguing work in the office or torturous boredom at home, the 2nd Saturday night has finally touched down for a light, relaxing, and pleasant get-together with the Brethren. The long excitement for a fellowship is not really to get drunk with the over-supply of beers but to give, receive, pass around and enjoy the abundance of friendship and Brotherly love.

6. It is finished. Christ knew His mission and in His dying seconds, He knew that it was about to be fulfilled. In a man's life, this is the time when he goes to the top of the hill, views the landscape, and rates his doings: Did I make the forest a tree greener? Did I sweep the gutter a cigarette butt cleaner? Or did I make a beggar's tummy a lugaw fuller?

Aside from these pious projects to advance a green environment and charity, Christ's final words also tell of an unconditional obedience to a certain command. Masonry has a string of tenets, principles and teachings which are meant to refine an "ashlar" and every ritual labors to process, improve, and purify both the initiates and the members beyond the earned degrees. The sublimity, beauty, and significance of these rites slice the Craft apart from the rest but the questions still nag: Do I follow them to the letter or are they, through a deliberate callousness to their meanings, got lost in translation? If I cannot answer these in a positive context, then I am not duly and truly prepared to live and breathe its sum and substance, then I should be ashamed – not proud – that I am part of its legion, and that the best way to give honor to its incorruptible name is by stepping out of its western door. As the visible and tangible face of Freemasonry, I just dismally portray it to be merely one of the clubs, to be more of the same, and one that is totally ill-equipped to make the difference that its charter has envisioned to bring about.

To be a better man is not a shirt imprint, a commercial slogan, or a homework sworn to be done by a snap of a pinky finger but a command that a Mason has obliged himself to do in a rite witnessed by God. It may be a work in progress and every process has a beginning. A person may have a bad start, a cursed middle game yet nothing prevents him from starting anew, from correcting his own wrongs, and from having an honorable finale. "Finished" is the time when, through a devoted knowledge and application of the rituals, the mission is met in making man a conscience clearer.

7. Father, into your hands, I commend my Spirit. This is the ultimate point where man puts his guards down and free flows his will in unison with the scheme of the one manning the control center and holding the master plan. For the faithful, nobody casts a doubt as to what may be inside the thoughts of the Supreme Being but rather, they completely trust that eve-

ry happenstance is in the agenda of the world's salvation. That Christ's suffering would be seconded by his ascension to heaven has been held as gospel truth since time immemorial because stones turned to bread and water into wine, Jonix graduated from Senior High School with honors, Fiona found herself a boyfriend, and some big dreams do come true courtesy of a little word - believe. While Freemasonry shares a parallelism in her belief in the Great Architect of the Universe, one feature stands out in her books and that is its compelling charge that man's purification starts with his avowal to clean his own mess and "improve himself in Masonry." The aim is to raise his body from the emblematical grave sans the superfluities of hatred, anger, fear, and all excess baggage of life that only tend to pull him down.

Changing a man into the mold of Freemasonry's ideals may take a while but yes, Azariah, there is now a cure for eczema. Nothing is too far nowadays. Man has reached the moon that is 384,000 kilometers away. Space X intends to land 2 Big Falcon Rockets (BFR) with human passengers on Mars which is 54.6 million kilometers from Earth. More recently, on September 25, 2017, Cassini Spacecraft made its final approach to Saturn which has a distance of 1.2 billion kilometers. Yet who needs rocket technologies to go to somewhere heavenly and significant. Man can reach the goodness in a heart that he can touch by just squaring his arm.

VR MURRAY BARTLETT, D.D.

FIRST PRESIDENT OF THE UNIVERSITY OF THE PHILIPPINES

A Priest? A Mason? An American? Hardly can you find such titles attached to a person. Only on the first President of the University of the Philippines, Dr. Murray Bartlett, born in Poughkeepsie, New York, on March 29, 1871.

Recipient of Master of Arts degree from Harvard University and a graduate of the General Theological Seminary in 1896, the Very Rev. Fr. Murray Bartlett was ordained priest and Rector of St. Paul's Church in Rochester, New York. Dr. Bartlett came to the Philippines in 1908 at the age of 37 to assume the deanship of the Cathedral of St. Mary and St. John in

Manila. When World War I broke out, he served in the US Army and attained the rank of Lt. Colonel. He was awarded the D.S.C. (U.S.) and Croix de Guerre and Chevalier Legion of Honor (France).

Aa a Mason, Ill. Bartlett was a member of the Rochester Consistory in New York under the Northern Jurisdiction. He joined the newly organized Lyceum of the Philippines and was elected Prior, the second highest position in the Lyceum. When Mt. Arayat Lodge of Perfection, Manu Chapter of Rose Croix, Confucius Preceptory and Gautama Consistory of the Philippines Bodies, which are existing up to now, were established, Bro. Bartlett participated in many of its conferrals. As a member of the Northern Ma-

sonic Jurisdiction, Bro. Bartlett limited his membership to the Lyceum. Ill. Barlett was crowned 33rd Mason by the Northern Masonic Jurisdiction, which he considered his greatest honor, he being the first of three great Philippine Masonic Educators thus honored – followed by Dr. Conrado Benitez and Dr. Camilo Osias.

Act No. 1870, which was enacted into law, ordained the establishment of the University of the Philippines. This development was without parallel in the Philippine history, for existing colleges then were missionary schools, heavy on religious orientation.

Sworn as the first University of the Philippines President in 1911,

"This then should be our watchword in developing the University of the Filipino – efficiency, founded upon scholarship and inspired by character."

Dr. Bartlett further said: "It is my conviction that if we have before us this ideal, our university will measure up to world standards, thereby carrying out the manifest provision of our Charter, but it must never be forgotten that this is and shall always be a University of the Philippines. It has been truly said that there can be no greatness without nationality. The world centers of knowledge are essentially national. With students from all parts of the world, Berlin is essentially German and Oxford essentially Eng-This University should not be a reproduction of the American university. If it is to blossom into real fruit, it must grow in Philip-

Filipinos. He founded the Graduate School of Tropical Medicine and Public Health; organized Medicine, Fine Arts, Agriculture (Los Banos), Veterinary Science, Engineering, Liberal Arts, and Law.

Dr. Bartlett served as UP President up to 1915, turning over the presidency to Dr. Ignacio Villamor, which was part of Dr. Bartlett's plan for the university: "A University by and for the Filipino."

In 1919, he was elected President of Hobart and William Smith College of Geneva, New York, serving the college until he retired in 1936.

The first President of the University of the Philippines was a Priest, a Mason, and an American rolled into one. Strange it may be but truth oftentimes is stranger than fiction. 🔉

INDOMITABLY BENEVOLENT

It was during the first Annual Communications held outside the City of Manila in 1987 when I first met VR Samuel P. Fernandez, PGC. He was one of our guests during a lunch hosted by our family for a Grand Lodge delegation led by MW John L. Choa, PGM. My late father, VW Raymundo L. Yu, Sr., PSGD introduced me to VR Sam whose name and face I was already familiar with because of The Cable Tow and Far Eastern Freemason issues that our parents

regularly placed on our reading table. Being awed by his stature, I was pleasantly astonished when VR Sam spoke on the level with me, then just a 21-yearold kid with 7 months of Masonic life. Even if we only conversed briefly, he left a lasting impression upon me that awakened my interest to pursue more light in Masonry. Such encounter convinced me that indomitable benevolence undoubtedly resides within worthy Masons and from thereon I looked forward to meeting more of such brethren. Afterwards, I often ran into VR Sam's frequent presence at the old Plaridel Masonic Temple whenever I attended the meetings of my mother lodge, Service Lodge No. 95. Even until now, instilled in my mind is a vivid picture of a robust VR Sam in his early 50s with a small portable camera tucked on his belt ever ready to take pictures of any precious Masonic moments

worthy of publication, and write about them.

However, it was not until 14 years later during the term of MW Napoleon A. Soriano, PGM in 2001 that I was able to work and serve the Grand Lodge with VR Sam. Once again, I was amazed seeing how he would work with the brethren in a collaborative and constructive manner. He immensely contributed to our planning discussions and would always accept with an open mind other ideas and concepts even when it meant his initiatives would take a backseat. After decisions were made, he fully supported the team decision and harmoniously labored. Indeed, an excellent actualization of our unifying principle of "who best can work and best agree."

After such term, masonic service again brought us together in 2005 when we actively implemented the Institute of Masonic Education and Studies (IMES). There I saw how he provided the necessary educational standards as we exerted efforts to formulate and implement a unified Masonic education system for our grand jurisdiction. Through the decades, I was also a witness to the dedicated service of VR Sam as he always answered the call of masonic service and served the brethren as: Grand Lodge Officer in numerous and different capacities, part of the various Grand Lodge Committees, active key Lodge Officer, lecturer, resource person, installing officer and guest speaker for lodge, district, multi-district and Grand Lodge affairs.

To narrate the achievements of VR Sam as a Freemason as well as the at-

tainments in his vocations as an educator, historian, journalist, theologian and ordained minister would likely fill up a large portion of this Cable Tow issue. Suffice it to say that VR Sam is an icon at Noli Me Tangere No. 42, our Grand Lodge, Blue Lodge Masonry and Scottish Rite Masonry. His significant and meaningful contributions to our official publication, The Cable Tow, and that of the Philippine Scottish Rite Masons, the Far Eastern Freemasons, is likewise so well-known among the brethren. But most appreciably, whatever VR Sam achieved without the Lodge, Freemasonry in our grand jurisdiction enormously benefitted. He brought to our Masonic Education system and IMES the standards befitting of an adult learning institution and provided depth in our research on the role of Freemasonry in Philippine history and nationhood. He broadened our minds with the insightful contents in the published issues of the Cable Tow where he continues to contribute articles up to now. He shared his deep study and understanding of religious faiths and enriched our understanding of masonic rituals and symbolisms. He redeemed the public image of our fraternity through his published letters by national dailies whenever misinformation tarnished it. He mentored both young and older Masons: and is still ever ready to answer their calls for assistance in Masonic service.

Despite his stature within and without Masonry, his character never changed through the years. In an annual communication during the early 2010s, he was unable to make prior hotel arrangements with his Lodge and joined our

Lodge delegation. I did not attend such communication and all in our contingent then were younger Masons, except for one honorary member. The honorary member was the only one among them who personally knew VR Sam. When they returned from such travel, I received nothing but praises on the exemplary conduct of VR Sam from all of them. They informed me that our esteemed brother displayed the discretion, virtue and dignity of an exemplary Mason and they deeply felt his sincere gratitude for allowing him to billet with them. A month thereafter, VR Sam also attended our Stated Meeting, and when I asked him if we oldies at Service Lodge No. 95 have taught our lodge successors well, he gave me a heartfelt smile that expressed a strong confirmation, and which gave us much delight.

As with any human institutions, misunderstandings and conflicts also beset the masonic journeys of VR Sam. Nevertheless, his fervent faith in our Supreme Grand Master and his genuine love for his brothers always prevailed. I saw his melancholic self when he attended the funeral rites of a departed brother who had unfairly offended him in the past. When our present Cable Tow Editorin-Chief, VW Rolando F. Rocha, GScb, asked VR Sam his secret for being a happy and healthy 88-year-old, he answered: "I do not harbor ill feelings against others because it only burdens me." His words and actions constantly remind me of our shared principle that on matters pertaining to the dynamics in our mystic circle, "we serve the brethren and our Grand Lodge, and that masonic personalities come and go." Those "secrets" were very instrumental in making our masonic travels worthwhile and joyful.

As we touched on the exemplary service of VR Sam in our Craft, it is unjust to not acknowledge the sacrifices of the family of VR Sam which enabled him to serve our Fraternity so well. Sis. Erlinda Asedillo Fernandez (Sis. Linda) and daughters, Ethel and the late Eileen, permitted the brethren to occupy much of VR Sam's time when he could have spent such moments with them. But with equal benevolence as VR Sam, they readily shared him with the brethren and even supported his service to our Craft. At present, Sis. Linda continues with her steadfast support to VR Sam in his masonic labors - a testament to her unconditional love for VR Sam and deep affection also for our Masonic Family. As evidence of their love and dedication for Freemasonry, such couple even chose for the location of their family abode a house that is both easily accessible to VR Sam's workplace and also the Grand Lodge. Masonic benevolence certainly prevails in VR Sam's family.

If I were asked if there is a phrase more than other phrases that best describes our worthy and exemplary brother, I would say that there is none more fitting than that he is and has always been an indomitable benevolent brother to all and for all seasons and those brethren who knew and served with VR Samuel P. Fernandez, PGC, will surely all fully agree with me.




"MW Don T. Ramas-Uypitching and the Brethren of Overseas" by Bro. JC Delos Santos

Before the convention, MW Don T. Ramas-Uypitching attended the 32nd Annual Installation of Officers for Emon Masonic Lodge No. 179 in Saipan. The event saw the installation of WM Fernando Enano, SW Carlos Eslaban Jr., and JW Raul Abordonado, with VW Elmer Balbin, PDDGM, serving as the Installing Officer. VW Wilfredo Boy Ching and VW Daniel Banez, Master of Ceremonies and Assistant Master of Ceremonies respectively. Following his speech, MW Don T. Ramas-Uypitching expressed gratitude for the prevailing harmony and unity.

Subsequent to the Multi-District Convention, the 61st Installation of Micronesia Masonic Lodge No. 173 unfolded. Worshipful Master Arthur Zantua and the lodge officers were installed, with VW Jose Carlo Delos Santos as the Installing Officer WB Arnel Zantua as Master of Ceremonies and WB James Padilla as Assistant Master of Ceremonies. The installed Master delivered his acceptance speech, followed by the introduction and message of MW Don T. Ramas Uypitching. Tokens and appreciations were exchanged during the fellowship dinner.

The Lodge was ceremoniously closed by VW Roland Gogue, emphasizing the harmony and unity prevailing among Freemasons, who, together, continue to build temples within the hearts of men. Around the island tour was done and fellowship lunch and dinner was also held in honor of MW Grand Master Don T. Ramas-Uypitching at the Guam Scottish Rite temple. The experience of brethren dwelling together in unity and concord was indeed a pleasant and enriching one.

ON FERTILE GROUND

Just as King Solomon reflected with regret in his older years, I am also reminded of the missed opportunities to better myself in Freemasonry and now seek redemption for the errors and omissions of my youth within the Craft.

From the Volume of the Sacred Law of my faith, it is written that: On the same day Jesus went out of the house and sat beside the sea. And great crowds gathered about him, so that he got into a boat and sat down. And the whole crowd stood on the beach. And he told them many things in parables, saying: "A sower went out to sow. During such times, I failed to recognize the noble purpose of the existence of our ancient and honorable institution. 
I recollect my days of youthful eagerness to attend as much lodge meetings and fellowships as I can. During those days, the maze of fanatical beliefs and prejudiced opinions that tend to be discordant overwhelmed me. Being illuminated by them and having failed in my attempts to better myself, I feel remorse for the eras when I fell on the path, on rocky ground and on thorns. With such realization, my spirit was renewed to continually examine my ways and persistently

endeavor to pursue light in Masonry. I shall now endeavor to remember our Supreme Creator no longer "in the days of my youth while evil days come not" but shall ever contemplate that "the dust shall return to the earth as it was: and the spirit shall return to God who gave it." May He create within me a fertile ground where I can faithfully plough to bring forth grains of goodness, a hundredfold, sixtyfold or thirtyfold in accordance to His will.



FELIPE BUENCAMINO, SR.

FIRST HONORARY PAST GRAND MASTER OF THE GRAND LODGE OF THE PHILIPPINE ISLANDS

MW Felipe Buencamino, Sr., first Grand Master of the post Philippine-American war, looms large in the masonic horizon for serving as Grand Master for four terms (1907, 1908, 1913 and 1914) under the Gran Consejo Regional, Gran Oriente Espanol. After the 1917 Philippine Masonry's unification, MW Buencamino served the Grand Lodge in various capacities until his election as Honorary Past Grand Master in 1925, at 76 years old. MW Buencamino, Sr. enjoyed his title until four years later, on February 6, 1929, to be exact, when he was summoned to the Celestial Lodge.

Early Life

Felipe Buencamino, Sr. was born on August 28, 1848, in San Miguel de Mayumo, Bulacan, to Victor Buencamino and Petrona Siojo. He was only 11 years old when his family moved to Manila in 1859. After completing high school, he took up a Bachelor of Arts degree at the University of Santo Tomas, graduating with honors. MW Buencamino stud-

ied canonical and Roman laws under Fr. B. Corominas and Jose Arrieta.

Civic Career

Bro. Buencamino Sr. earned his law degree at the University of Santo Tomas in 1884. He went to work

(court) and was eventually promoted fiscal.

He served as a registrar of property in Ilocos Sur in 1891.

Then was appointed ad interim judge of the Court of First Instance of Tayabas (1888) and Batanes (1896).

Spanish Military Career

At the outbreak of the Philippine Revolution in 1896, Buencamino, Sr. was still working with Spanish government. Gov. Gen. Primo de Rivera appointed Buencamino Sr. as honorary lieutenant in Pampanga. On October 16, 1897, he was decorated with the Cross of Carlos III after he prominently figured in the battles of Kamansansi and Mount Arayat. Gov. General Agustin appointed Buencamino Sr. as lieutenant colonel of the Voluntary Force which was composed of 800 soldiers. Buencamino made remarkable and notable

engagements in San Antonio Abad, in Zapote Bridge and in Muntinglupa.

Filipino Revolutionist

Accused by the colonial authorities of being a Filipino spy, Buencamino was thrown into prison on Osorio, Kawit. Governor General Agustin later freed him, but Buencamino found the experience so repugnant and revolting that he decided to cast his lot with the Filipino revolutionist.

On June 12, 1898, Buencamino actively participated in the proclamation of Philippine independence in Kawit, Cavite as a new comrade-in-arms.

General Aguinaldo appointed Buencamino as a Secretario de Fomento (Secretary of Public Development) on September 26, 1898. He was one of the members that drafted the constitution of the Malolos Republic.

Upon order of Gen. Aguinaldo, Buencamino investigated the killing of a Filipino corporal in Sta. Mesa and put the blame squarely on the American forces. Buencamino became the director of the military tribunal with the rank of Colonel during the outbreak of the Philippine-American War. He resigned from this post in June 1899. On November 17, 1899, Buencamino Sr. was captured by American troops.

American Regime

United State Secretary of State John Hay had sent a telegram to the Schurman Commission offering the Filipinos autonomy under American authority. Buencamino was among those who lobbied for the acceptance of American control and domination of the Philippines. While the Philippine-American War was still raging, Buencamino and Pedro A. Paterno formed a group known as the Pacificados. They organized what was called Asociacion de Paz (League for Peace). The goal was toa id General Elwell Otis' pacification campaign. Among its prominent members were known members of the Craft: Trinidad Pardo de Tevera, Leon M. Guerrero, Rafael Palma, Justo Lucban, Pascual H. Poblete, and Cayetano Arellano. In December 1900, the league changed its name to Partido Federal dominated politics until 1907 when Nacionalistas advocated independence.

In 1901, Buencamino became a member of the Civil Service Board. In 1902, he visited the United States of America.


Legacy

MW Felipe Buencamino, Sr. led a colorful life. He was one of the founders of the Philippine Independent Church. He became president of the Presbyterian congregation of Tondo. MW Buencamino is the only Grand Master who served four terms under the Gran Consejo Regional, Gran Oriente Espanol.

Granted an Honorary Past Grand Master in 1925, his dedication to Freemasonry is without equal. At age 76, he was an epitome of dedication and devotion when he received the honor of Honorary Past Grand Master of the Grand Lodge of the Philippine Islands.



Masonry brings people together irrespective of color (race and political affiliation), religion and differences that can divide us.

CHARITY, among Masons, is the greatest. It is imbued in every heart of Masons which is manifested by the several Masonic clubs doing their respective Masonic charities in the community. Among others, one of the duties of their Lodge to the community is "to assist and participate in worthwhile commu-

nity projects". Within its Masonic organization, it has a structure of Masonic relief to their brethren in need as taught in the three (3) degrees of Masonry.

PLANS AND PROGRAMS

As before, I am adopting my Plans and Programs which was submitted when I was first nominated for the elective position of JGW.

Masonic Unity. We should admit that the disunity on several reasons has divided the brethren, even in the Grand Lodge. To name some, we are hearing fraternity within the fraternity, the anarchy of the few, the abuse of the majority and the discontent of the unsatisfied which were unattended and, despite violations of our Masonic laws, they were disposed in the guise of "harmony" leaving the disputes unresolved. Divisiveness is a manifestation of immaturity in our Craft. "Masonry builds good people" for better, and it "provides the common foundation for friendships between members". "Being a Freemason means something different to each person who joins, but whether looking to make acquaintances or develop their own potential, all members share a sense of togetherness that strengthens their ability to succeed and grow" in unison.

In this regard, one of my proposals is to revisit the policies on the handling of complaints and rendering its decisions from the Lodge and the harmony officer to the trial commission, the Committee on Grievance, the Grand Master and appeal to the Grand Lodge during ANCOM, thereby amending the provisions of the Masonic Law Book on these matters.

Masonic Relief. Being taught deeply in every Mason's heart, one of the most important tenets of Masonry is RELIEF, thus, "kindness and charitable giving are deeply ingrained within the principles of Freemasonry". AID AND RELIEF activities of the several Masonic clubs and organization will be consolidated to serve our community "through mission-driven charitable programs and services that exemplify Masonic Values".

For the Brethren, an improved Masonic Health Care Benefit of the existing FRAP and PM monetary benefit, establish a Home Care for the Elderly and Distressed Masons, which may include health and medical care through accredited health care institutions, and revisit our policies on, and protect

and establish more Masonic cemeteries, especially in our Districts.

Masonic Hospital. While a more comprehensive health care system would make a great and positive impact to our Brethren and their immediate families, this would still be dependent on the availability of health care institutions that can provide quality service at an affordable rate. I propose the establishment of a system of a Masonic Hospitals, starting with a prototype, hopefully during the four (4)-year journey to the Grand Oriental Chair. This hospital system shall be patterned after a certain "Medical Center" business model and will be built on the network of our Brethren-Doctors, who will function both as owners and medical practitioners, and also our Friends of Masons-Doctors who would be interested to invest in this Grand Project. Having our Brethren as owners, we are therefore assured of a sustainable supply of medical professionals and facilities available to them and their families, and we may also be able to allocate a portion of its functions to charity.

In addition, a Revisit of the Functions of the Committee on the Administration of Lodges, Char-

ter and Return. Many cases of unMasonic conduct over the past few years are of the nature of violations of Edict 328, whereby unfortunately, some of our brethren have taken advantage of their several positions by abusing their authority over the aspirants to our Craft. Although we have a robust system which is already in place for its prevention, I believe that this can still be improved. I therefore propose the initial establishment of a Sub-Committee on Membership Development under such Committee. Among others, its function is to act as an Oversight Committee on the progress of petitions and conferrals of subordinate Lodges, and also to receive and give preliminary assessment to complaints filed in relation to alleged violations of Edict 328, and institutionalize the mentoring of newly obligated brethren towards Masonic maturity. In addition, this Sub-Committee will serve as Technical Working Group to come up with an instructional program for candidates and new members which may be called as "Mentoring and Education Program".





The diagram of proposed programs intersects and is centered on the principle of Harmony and cooperation among brethren. The commonalities harnessed by the power of member's collective common goals should be the driving force to achieve programs for the continuing relevance of freemasonry in the Philippines.

The Craft & GLP for the well – being Of learners & the environment.

Our common goals aspirations will bring about harmony.

Plans and Programs for the Fraternity.

For the Craft & Grand Lodge of the Philippines

A.I Mother Lodge Prioritization

Members must be fully committed to their Mother Lodges to ensure vitality and vigor. Brethren must at all times give priority to their Mother Lodges over appendant bodies, clubs or Masonic clubs they belong to.

In case of conflict in schedules between the Mother Lodge and appendant body or club, the Mother Lodge schedule must take precedence. Equitable share of the Mother Lodge in the petition fees, donations and the like to an appendant body or club by the Brethren is also recommended.

A.2 Further Improvement of Masonic Legal Processes

The growing number of cases filed between Brothers must be properly managed. The Grand Lodge must focus on the cases with clear probable causes for unmasonic conduct/s or complaints. Verified complaints, that are clearly actionable must be prioritized. All baseless complaints must be discouraged or dismissed outright without prejudice to anonymous complaints if from verifiable sources supported by evidence.

Harmony is the goal. Brethren must exert and exhaust all efforts to mediate/ arbitrate issues between Brethren before they become full blown cases. This will be the exact task of Harmony Officers of Lodges with the support of elders in the Lodge or district possessing impeccable Masonic moral ascendancy.

The Grand Lodge shall continue to address and resolve cases filed with utmost scrutiny and dispatch. Legal processes must be streamlined and enhanced to prevent clogging of cases. Field Investigators may be appointed from a separate district who may even be given the authority to conduct investigation of anonymous verifiable complaints against erring Brethren of another district.

The use of modern technology shall also be the standard means in the submission and service of complaints, affidavits and the like including submission of Lodge reports. For the Brethren and their Families

B.I District Masonic Aid Centers

Brethren with legitimate concerns need guidance or assistance. Districts and Lodges must be involved in the well-being and health conditions of Brethren, Immediate Family, Widows and Orphans in dire need.

Every subordinate lodge, thru the Worshipful Master as the overseer of his brethren, must at all times give priority to the needs, health and well-being of the members before any charitable activity for the community.

B.2 District Rescue Brigade

Brethren, Immediate Family, Widows and Orphans must have sense of health security especially in the immediate transport needs of those with illness. It is suggested that Masonic Districts must have medical transport vehicles for the needs of Brethren or even the communities in the district.

The same transport vehicle may also be used during natural calamities to assist the Brethren or their families or even the community to alleviate the suffering of those in distress.

For the Country and Environment

C.I Adoption of Schools Districts by Masonic Districts

The public school system is one of the most important sectors of the society. Freemasons must do what it can to help the children thereby ensuring the future of our society. The institutionalization of the adoption of schools is the goal to ensure the continuity of as-

sistance programs for students in the public school system. Regular participation of Lodges in "Brigada Eskwela" is likewise recommended. Thus, every subordinate lodge must adopt at least one (1) public school within their masonic district. This will also ensure that indigent learners will have opportunities similar to those in private schools. After school programs for public schools is needed to prevent children from being influenced by the underworld or by negativity of thought or belief. Masons can help public schools through programs and activities in and outside the schools.

C.2 "One -100" Program (1 Lodge, 100 trees, 1 Masonic Year)

We are all part of a society that needs to lead and take part in helping the environment. Mason's greatest strength is the power of "common goal". Projects and programs for the greater good can be implemented seamlessly and effectively by the sheer number and dedication of Brethren working together towards the same objective or aspiration.

The minimum number of frees every subordinate Lodge must plant shall be based on the number of active members submitted by the lodge Secretary in its Annual Report to the Grand Lodge of the Philippines.

This power must be harnessed properly for the greater good of the environment. The concrete jungle of the city has become more and more unbearable for the people especially the children. 'Harmony being our strength and the

fundamentals of Masonic Teachings being our guide, we fervently hope that all these plans and programs may come to fruition for the benefit of the Brethren, their Families, the Community, and the Environment, in particular, and the Blue Lodges, Appendant Bodies/Masonic Clubs and the Most Worshipful Grand Lodge of the Philippines, in general.

"Bridging Gaps in Archipelagic Masonry through Healthy, Happy and Caring Freemasons."

Philippines has a great number of cultures, traditions and beliefs, dividing its citizens including masons. These diversities in cultures, traditions and beliefs are real and cannot just be ignored and brushed aside as they cause misunderstandings, confusions, struggles and serious conflicts within organizations, fraternities and even in communities and countries. On the other hand, such diversities, when properly understood, bridged, and linked can bring about -a broader display of insights, concepts, designs, and creativity,

leading to teamwork, inclusiveness, unity, and greater accomplishment. In our beloved fraternity, despite our diversities and differences and despite living in the different parts of our country with different cultures, languages, and dialects, we always find ways to bridge and fill those gaps of diversities. In this regard, I do believe that a genuinely Healthy, Happy and Caring brotherhood of Freemasons is the key to understanding and bridging said diversities or differences akin to archipelago which is an "island group" or "a chain, cluster or collection of islands". Although the islands comprising the archipelago are separate, they are, nevertheless, considered as one group or chain of islands linked together forming the archipelago. In masonry, the chains or bridges that connect the brethren of different cultures, faith and ethnicity are the three (3) core principles of Freemasonry: Brotherly Love, Relief and Truth. All sick masons regardless of GLP standing and all Philhealth accredited Filipino citizens shall be accommodated free of charge;

To give every Master Mason, regardless of age and social status, an annual insurance, as a token for the honorable services he rendered to the lodge with great sacrifices of endangering his life from multiple travels using roads and other health hazards while performing masonic related works or activities;

To instill in every Mason's heart and mind that he has the duty and obligation of maintaining and supporting the existing laws, the constitution, edicts, rules and regulations of the Most Worshipful Grand Lodge of Free and Accepted Masons of the Philippines, it having been perfected by great and honorable brethren ahead of us, He only wants to impress upon every mind of every brother the understanding of every minute detail in those existing laws, the constitution, edicts, rules and regulations. In so understanding, thus a mason truly knows where to find eternal happiness, internal or external, expressive through his words and actions as a humble man and a mason.

An effective feedback mechanism should be devised that the blue lodges will have effective means of evaluating the programs and affairs of the Grand Lodge. A sense of co-ownership by the blue lodges in the thrust of the Grand Lodgc will augur well in enlisting the support and active participation of the Brethren.

Towards this goal, the Grand Lodge Inspectors, should be aptly prepared and empowered to receive feedback by the respective lodges on the thrust of the Grand Lodge as part from the reports regularly submitted.



Regular area or cluster meetings among the different Masonic Districts, apart from the Multi-District Conventions should likewise be encouraged and institutionalized, particularly those outside of the National Capital Region where the different districts are separated by territorial and geographical boundaries.

The remote/ online communication and financial facilities of the Grand Lodge should be kept abreast to give the Brethren real-time access, including payments reflected in real time.

A support plan for the different Masonic youth organizations should be devised The Masonic Districts and the lodges should be instructed to appoint a Designate for Demolay chapters and other Masonic youth organizations housed in their lodge temple or within the District. It should be the duty of the lodges to help and sustain the chapters in their area and provide valuable support and endless supply of rolemodels for the youth.

LUMILIKHA, LUMILINANG.


It cannot be emphasized enough that there should be a premium on quality over quantity in the admission of candidates, as well as in the creation of new Lodges. There must be regular Lodge Certification examination, not just during turnover between the present and newly elected set of officers, on each lodge to be conducted by the Grand Lodge through its representative to ensure that the lodges are proficient in the rituals and lectures. Should the lodge fail anent the standard set, all

its officers and members should undergo refresher course on the rituals and lectures.

Towards building character, Masonic Education should also give emphasis on Humility, Charity, and especially, Tolerance/ Toleration.

In nurturing the youngest members of the Lodge, the newly raised Brethren should be given all the opportunity to be heard on what they learned during their immersion in the trestle board and in the quarry, and of their expectations of the Lodge and of the Craft. Admittedly, the rituals by themselves will not make good men better; the proficiency examination is limited to the catechism. There must be equally faithful attention on the carefully constructed after-ritual explanations apart from the structured lecture on the degree, as well as constant and positive interaction with the older members of the Lodge and proper guidance by the officers, at least for the next year or two following their raising to the sublime degree, as way of reinforcing the positive character of the youngest Brother of the Lodge.

A form of Masonic Skills Record should be considered for use in evaluating the skills, talent and interests of Lodge members, whether seasoned or newly raised. The information so obtained will be a valuable resource in tapping previously unknown talents and skills of the Brethren which the lodge can utilize for its labors, and corresponding membership development programs developed.


